### **OFFICIALS:**

### **GAME MATCHES:**

Memphis now consist of Area 1 (North & Central Division) and Area 2 (East and South Division), which means that each division has to play out in their perspective areas to qualify for West Tennessee Sectional Tournament play. All matches shall be best two out of three games using rally scoring (point scored on each serve). Games shall be played to 25 points with no cap (no cap means a team must score a minimum of 25 points and be ahead by at least two points to win a game). Should a match go three games, the third game shall be played to 15 points with no cap.

### **VOLLEYBALL EQUIPMENT:**

When your school is hosting a match, it is the responsibility of the home school to provide safe and adequate equipment for the match. If the home school is unable to provide safe equipment, it is their responsibility to secure another site. The school must notify the MIAA office, Mickey Pitts, and the other teams of the changes within a 24-hour period.

### **REGULAR SEASON/ TOURNAMENT GAMES:**

According to the TSSAA Sports Calendar the number of regular season contests in girls middle school volleyball is (20) twenty matches. Furthermore, tournaments shall count as (2) two games, which means that each MIAA school participating in this year's volleyball season can actually play (16) sixteen regular season matches. The MIAA City Championship play-off and game will count for two. The TMSAA Sectional Championship play-off and game will count for two (2) which will give you a total of 20 matches for the season.

### **NON-LEAGUE MATCHES:**

If your school is not scheduled to play during a particular week you may contact other teams not playing on the same date and schedule a non-league match to complete your schedule. Remember, you only have (16) sixteen regular season matches to give.

### **RALLY SCORING:**

Scoring will be set up for tournament style play with the best 2 out of 3 matches. The first two matches will be played to 25 points with no cap and the 3<sup>rd</sup> game will be played to 15 points with no caps.

### **ELIGIBILITY LIST:**

TMSAA Eligibility Report & Schedule is due 1 week before your first contest directly to the TSSAA and copies to the MIAA office.

### **INSURANCE:**

All participants must be insured. For more information, please contact Jay Phillips 901.828.3080. Insurance is due **Thurs., September 4, 2008**. The cost is \$5 per athlete.

### **MIAA CITY CHAMPIONSHIP TOURNAMENT: SEPTEMBER 19, 22 & 24 2008**

\*\*\*\*\*The MIAA City Championship Meeting will be held Thursday, September 18, 2008 at 3:00 p.m. at the MIAA office to determine what teams will be playing for the city championship\*\*\*\*\*

The coach or representative must be at this meeting with their season record to be included in the championship game. If a representative is not present the following will occur:

- a. Removal of the coach for City Championship series and the coach will not be allowed to attend the play-offs and/or City Championship game.
- b. The day of the City Championship meeting all schools must fax their records or entry forms to the MIAA Office by 9:00 a.m.
- c. A school that does not attend the City Championship meeting must pay a \$500.00 fine to be included. The fine will be payable before participation in tournament play and will be awarded to any school that is removed from the tournament. Exception for Track & Field only: The teams will be allowed to participate as open lanes permit.
